

## **NORTH PEACE SAVINGS AND CREDIT UNION (NPSCU)**

### **YOUR VOICE – OUR FUTURE MEMBER SURVEY (THE “CONTEST”)**

#### **OFFICIAL CONTEST RULES (“Rules”)**

**CONTEST PERIOD:** The Contest starts on March 8, 2021 at 8:00 AM Mountain Standard Time (MST) and ends on April 1, 2021 at 11:59 PM MST (the “Contest Period”).

#### **ELIGIBILITY:**

The Contest is open to Members of NPSCU nineteen (19) years of age or older on the date the Contest ends. NPSCU employees, directors and family members living in the same household as an employee or director are not eligible to win. To be eligible to receive the Prize, the Selected Entrant will have to correctly answer a time-limited, skill testing, mathematical question.

**NO PURCHASE NECESSARY.** There are two (2) methods of entering the Contest, as follows:

#### **HOW TO ENTER**

**Method 1:** NPSCU Members 19 years of age and older as of March 8, 2021 will receive an email request to complete an online survey. Once the survey is completed, you will be asked if you would like to be entered into the contest. If you agree, your name will be entered into the draw.

**Method 2:** NPSCU Members 19 years of age and older as of the contest end date (April 1, 2021) may enter the contest without completing the survey by emailing their name, complete address, and telephone number to [membersurvey@npscucanada.com](mailto:membersurvey@npscucanada.com)

#### **LIMIT:**

There is a maximum of one (1) entry per NPSCU Member aged 19+ years.

### **THE PRIZE:**

One (1) prize is available to be awarded to the selected entrant (“Selected Entrant”) of the Contest as deemed by a random draw. The prize consists of a 1 Year Non-Redeemable Term Deposit held at NPSCU in the value of one thousand dollars (\$1,000 CAD) (the “Prize”). The Term Deposit will be issued in the Selected Entrant’s name, within their NPSCU membership, within two (2) weeks after the draw held on April 6, 2021. The Term Deposit will yield interest at the Credit Union’s applicable interest rate as posted on its website *npscu.ca* on the date of its issue. The Prize is not transferable and must be accepted as awarded.

The Selected Entrant is solely responsible for reporting and paying all taxes, if applicable, resulting from claiming the Prize.

### **WINNER SELECTION AND NOTIFICATION:**

A random draw will be conducted on April 6, 2021. The Selected Entrant will be notified by phone/and or email within approximately one (1) week of the draw date.

### **PERSONAL INFORMATION:**

The personal information of all Contest Entrants is protected by NPSCU’s [Privacy Policy](#).

### **DECLARATION AND RELEASE:**

To receive the Prize, the Selected Entrant will be required to sign a copy of these Rules, thereby declaring to NPSCU that they:

- Have complied with and agree to the Rules and accepts the Prize as offered;
- Acknowledge and accept the non-responsibility of NPSCU and the Prize suppliers and their agents in respect to injuries, accident, loss or misfortune relating to the Prize; and,
- Permit NPSCU and their agent’s publicizing, by all forms of media their picture, name, address, voices and statements without further compensation other than the Prize offered.

If the Selected Entrant does not meet these requirements or cannot be contacted by NPSCU after at least five (5) attempts during the two (2) week period after the draw or is contacted but unwilling or unable to comply in full with these Rules, the Selected Entrant will be disqualified and NPSCU may, at its sole discretion, randomly select another entry in place of the disqualified entry.

**CHANCES OF WINNING:**

The chances of winning are dependent upon the number of eligible entries received.

**CONTEST LAWS AND REGULATIONS:**

The Contest is subject to all applicable Federal, Provincial, Municipal and local laws and regulations. The Prize is non-transferable and must be accepted as awarded with no substitution except at the sole and absolute discretion of NPSCU. NPSCU is not responsible for lost or incomplete entries. NPSCU reserves the right to discontinue the Contest or alter the Rules at any time.

**DISQUALIFICATION:**

NPSCU reserves the right to review all entries and to disqualify from participation any person whose entry does not comply with the requirements set out in these Rules.
